\* The IRS does not guarantee a specific date that a refund will be deposited into a taxpayer's financial institution account or mailed.



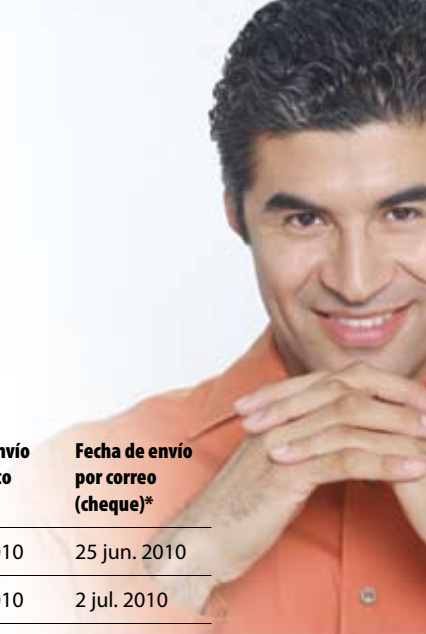
